





1. Pursuant to Division Memorandum No. 127, s. 2016 re: Call Up for Teacher Applicants in Junior High School, applicants are hereby informed of the scheduled English Proficiency Test (EPT) on July 2, 2016 at 10:30 a.m. at San Jose Pili National High School, San Jose, Pili, Camarines Sur. This EPT will be administered by the representative of the Bureau of Education Assessment (BEA).
2. Applicants who took the English Proficiency Test (EPT) last March 8, 2015; July 11, 2015; March 19-20, 2016 and May 29, 2016 need not take the said examination.
3. DepEd personnel and room examiners involved in the conduct of the test are entitled to an overtime claim on a Compensatory Overtime Credits (COC) basis consistent with the existing rules and regulations.

5. Travel expenses and other incidental expenses may be charged against MOOE subject to the usual accounting and auditing rules and regulations.
