## -CONTRACT AGREEMENT

**Project: REPAIR/REHABILITATION OF DIVISION OFFICE CANTEEN AND DORM WITH COMFORT ROOMS**

### KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between the **Department of Education, Division of Camarines Sur**, a Government Entity existing under and by virtue of the laws of the Republic of the Philippines, represented herein by **GILBERT T. SADSAD, Schools Division Superintendent**, with Office Address at *San Jose, Pili, Camarines Sur, Philippines*, herein now referred to as the "PROCURING ENTITY"

- and -

**JAN-SHA CONSTRUCTION AND SUPPLY**, a company duly organized and existing under the laws of the Republic of the Philippines, having its principal place of business at VGHS, Concepcion Grande, Naga City, represented herein by **ROSALINDA N. GAMBA**, PROPRIETESS/GENERAL MANAGER, now herein referred to as the "CONTRACTOR"

### WITNESSETH:

That the **PROCURING ENTITY** invited bids for Civil Works viz; **REPAIR/REHABILITATION OF DIVISION OFFICE CANTEEN AND DORM WITH COMFORT ROOMS**, and has accepted a Bid by the **CONTRACTOR** for the execution of those Civil Works in the Sum of **ONE MILLION FOUR HUNDRED NINETY SIX THOUSAND NINE HUNDRED SIXTY TWO PESOS AND 22/100 ONLY (Php. 1,496,962.22)** hereinafter called "THE CONTRACT PRICE".

1. That the following documents shall be deemed to form and be read and construed as part of this contract, viz;
  - A. The Duly Signed Bid Form;
  - B. The Duly Signed Bid Prices in the Bill of Quantities and Detailed Estimates;
  - C. The Duly Signed Cash Flow by Quarter and Payment Schedule;
  - D. The Procuring Entity's Resolution to Award;
  - E. The Procuring Entity's Notification to Award;
  - F. The Procuring Entity's Notification to Proceed;
2. That in consideration of the payment to be made by the **PROCURING ENTITY** to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the **PROCURING ENTITY** to execute the Civil Works, and to remedy defects therein in conformity in all respects with the provisions of the General Conditions and Special Conditions of the Contract.
3. That the **PROCURING ENTITY** hereby covenants to pay the **CONTRACTOR** in consideration of the provisions of the civil works, remedying of the defects therein, the **CONTRACT PRICE** or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the General and Special Conditions of the Contract.
