KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between the Department of Education, Division of Camarines Sur, a Government Entity existing under and by virtue of the laws of the Republic of the Philippines, represented herein by **ARNULFO M. BALANE, CESO V, Schools Division Superintendent**, with Office Address at *San Jose, Pili, Camarines Sur, Philippines*, herein now referred to as the "PROCURING ENTITY"

WITNESSETH:

That the PROCURING ENTITY hereby covenants to pay the SUPPLIER/CATERER in consideration of the provisions of the goods and services, remedying of the defects therein and the replacement of the goods as rated defective by the Committee of Inspectors, the CONTRACT PRICE or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the General and Special Conditions of the Contract;
